Please come prepared! View the back of this page to view a list of acceptable documents that you can bring in to be verified by the Recreation Department. ***No photocopies are allowed due to government regulation***

For employees ***15 and under*** please come prepared for your work permit. Your parent or guardian will need to sign a form for this to be issued. Please note that for a work permit, you will need one of these documents specifically: Birth Certificate, Baptismal Certificate or a State photo ID or License along with a social security card.

How do I get paid??

Please be sure to ask one of our office team members for a direct deposit slip as this is the easiest and most convenient way for you to get paid! If you do not sign up for direct deposit, your check will be held here at the office for 1 week from the pay date. Either you or your parent may pick up your check with photo ID. If you do not pick up your check, they are mailed to your address on file after one week.

All documents must be **UNEXPIRED**

Employees may present one selection from List A
or a combination of one selection from List B and one selection from List C.

5. For a nonimmigrant alien authorized to work for a specific employer because of his or her status: a. Foreign passport; and b. Form I-94 or Form I-94A that has the following: (1) The same name as the passport, and (2) An endorsement of the alien's nonimmigrant status as long as that period of endorsement has not yet expired and the proposed employment is not in conflict with any restrictions or limitations identified on the form.		5.
